## **1 Review of minutes from last meeting**

Minutes from last meeting were approved as presented.

## **2 Opening Remarks (President/Other)**

Discussions focused on snow removal on Marshall Street field to try to prepare for the Scorpion Bowl. The contractor failed to remove the snow so the Scorpion Bowl at Marshall Street was cancelled.

## **3 Treasurers Report**

Treasurers Report was given. Deposits, Shamrock Ball, Maintenance costs.

## **4 BAYS Report**

Wednesday evening, BAYS BOD met at the Wellesley Community Center for its March meeting. Points of interest:

- 1) Division Directors will be given more clear definition and guidelines for selecting and moving teams during the season. BAYS has the right and responsibility to move teams that have been improperly placed, regardless of the protests of the parties involved. Records thru week 5 will be used to determine likely candidates.
- 2) Levon A. will assume the duties of Referee Director previously handled by Paul Snover, recently retired.
- 3) MTOC eligible teams will be subject to pass card review after the post season semi-final BAYS playoff game. Pictures of the players need to match the players or be updated. Passcard stickers will be distributed for the players' cards after review is completed.
- 4) A U13 recreational section will be offered by BAYS in the Fall of 2011 / Spring 2012 season. These will be D3 and D4 sections. U13 teams that wish to compete in the year end MTOC playoffs will continue to be required to play in the U14 age group, as MTOC does not acknowledge U13 as a separate age group.
- 5) Massachusetts Youth Soccer Association will be conducting their Annual General Meeting Saturday 3/5/2011 at the Four Seasons Hotel in Leominster/Lancaster. All towns are encouraged to send representatives. Meeting begins at 10:00 AM, continental breakfast is supplied and registration starts at 9:00 AM, and the entire event should conclude by 12:15 PM.
- 6) Meeting was adjourned and the annual team seating swap meet began. Wendy represented Holliston and may still be wheeling and dealing.
- 7) Bruce encourages teams to enter the Presidents Cup, \$25 fee. Midweek game. Information on the Bays website.

## **5 Registrar Report**

650 players signed up as of 3-3-11

Numbers are down in High School and U8 boys, other groups are at consistent levels.

High School Boys: 11 players registered at this point, emails are being sent out to recruit another 7. Goal of 18 players

High School Girls: 16 players registered so far, mostly younger players. Goal is to recruit additional players to have enough for two teams.

## **6 Girls Travel Report**

---

Placements went great, 3 moves were made.

Numbers are fine, U14 teams are above average, 16-18 on each team. Positive outlook on the spring season for U14 girls

U12 numbers are in good shape

U11 numbers are tight, 33 players on 3 teams, hoping for 2 more kids for two parity teams. Two teams are not an option. We are also looking for a coach to replace Campbell, looking to email parents for another coach.

## **7 Boys Travel Report**

---

U14 Boys: total of 41 boys, 18 on one team and 23 on the other. Creating 3 teams is not a good option because of attendance on game day due to baseball and other activities.

U12 has 26 players, 12 on one team and 14 on the other team

U11 has 30 players, teams of 13 and 17 players.

The combined U11/U12 team option of the fall was removed because we did not want to ask just two U11 players to play up to U12.

## **8 U10 Girls Intramural Report**

---

54 players so far, keep at 6 teams, try not to drop to 5 teams to avoid the double-headers.

Unsure about 2 coaches; waiting to hear.

## **9 U10 Boys Intramural Report**

---

47 players, at least 2 more to come. 4 teams, want to avoid 5 teams.

Coach sign up is a problem, 2 teams of coaches, looking to create 2 more.

## **10 U8 Girls Intramural Report**

84 players, could stay at 12 teams. Coaches taking G course which is positive.

## **24 Old Business**

---

*There was discussion at the February meeting regarding why there isn't U9 Travel. The discussion was tabled until March*

At the March 3<sup>rd</sup> HYSA meeting the topic of a creating and or moving to a travel format in the U9/U10 age groups was discussed. Many of the opinions are listed below and help to highlight the positive and thoughtful participation of the attendees.

- The topic should be presented to general parents
- Some kids will stay in HYSA and not go off to club if they can do travel at the U9 age
- Some kids will stop playing HYSA if they are forced to travel at the U9 age
- There are players who stop playing at U11 due to the need to travel. They don't want to deal with travel.
- Why do kids stay or leave the program - club soccer, other sports, some leave HYSA in third grade to play club and then return in fourth grade to play select travel.
- There is value in both town soccer and club soccer for an individual player
- Football and lacrosse numbers are up, is it because they travel? Football and lacrosse have two and three teams in age groups so they must travel.
- Does it make sense from a soccer training perspective to have a U9 travel team?
- There will be an impact on the roster numbers of the U10 teams.
- Generally the numbers of U9/U10 players in the program will dictate the need for travel.
- A four team minimum is required for a town intramural program.
- Other towns that do not have the numbers to field a U9/U10 intramural program do have to travel but often attempt to schedule games close to town. We are approaching a point where our numbers could warrant us doing a spring U9/U10 travel program.
- A league of neighboring towns would be desirable.
- The town of Franklin has solicited neighboring town teams to join their semi private program.
- Making an intramural town team into a travel team will not improve the competition since the players are the same.

- Not in favor of having to choose a select team from U9 players. Stress to 2<sup>nd</sup> graders in selection process too great.
- U9 players should still be working on basic skills and are not yet ready for team skills.
- Suggestion to have all U9 and U10 teams become parity teams thus eliminating tryouts.

Any travel option changes could happen in fall at the earliest. Fall teams must be decided and submitted to BAYS by July.

This topic needs to be researched in more detail. To make a big change of this nature will require more than a discussion.
