- Marshall Turf Replacement
 - o Loan for turf replacement tabled
 - o Project to cover turf replacement, border and drainage
 - Several options available for turf replacement each associated with a different cost, e.g. rubber, cork, coconut husk, ...
 - o Possible expansion of width to construct four 9 v 9 fields
- Proposing to increase player registration fees
